HEALTH OFFICER'S REPORT

Michael Balka, HO said "we are at the end of the quarter, so there has been a lot of activity with the grants; there was a rollover function with the vaccine grant, and I was able to identify approximately \$25,000 that has now been freed up to be used going forward. A lot of prep is being done in anticipation of our move in November, and I am still working on modifying the Policy and Procedure manual".

HUMAN RESOURCES COMMITTEE:

No report at this time.

BUDGET & FINANCE COMMITTEE:

Tom Rogers reported the committee had a good meeting with Gail, and Michael to review where we think we'll finish for the year, and what we would return to surplus. We expect to return the same to surplus that we used this year, and perhaps a bit more. For 2024 we may use a little surplus, but we expect the surplus to be offset by grant funding; some of which we have already received, some we will receive in June of 2024. We have also adjusted the budget to recognize the reduction in workforce, and our new lease agreement.

CFO REPORT:

There will be a 12.5% assessment increase for all municipalities. We have added a couple of budget lines to the 2024 budget as recommended by our Auditor to prepare for any change in operation in the future. Today is just the introduction of the budget. After discussion and review of budget introduction Tom Rogers made a motion to accept this introduction, which was seconded by Bryan Dempsey of Spring Lake.
