It is the recommendation of the HR committee that the following positions be eliminated; Vulnerable Population Outreach Coordinator, Peg Huie. Public Health Nurse, Belvin Reed-Stanislaus and Communicable Disease Investigator, Ashley Lafferty. This will be effective as of October 27, 2023; we thank these employees for their service to the Health Commission, and wish them well in the future.
