Performance Management for Immediately Reportable and 24 Hour Reportable Communicable Disease:

- Immediately reportable diseases are responded to and investigated immediately 100% of the time.
- 24 hour reportable diseases are responded to and investigated on the same day, or on the next day 100% of the time.
 - *Included in this report are MCRHC towns and Middletown.
- There has been a 25% decrease in Total Number of Reported COVID-10 cases since September 2021
- For the month of October 2021, there as been a 27% decrease for Confirmed Positive Cases of COVID-19
- MCRHC (and Middletown) cases have seen a slight decrease in the numbers for non-COVID communicable diseases for October 2021.
